## **NORTHERN CALIFORNIA INTERGROUP MINUTES**

# August 27, 2024

**OPENING MEETING:** The meeting was called to order by Michele G, Intergroup chair, at 6:00 p.m. The Serenity Prayer started the meeting, followed by the reading of the 12 Traditions (Larry T.) and the Statement of Purpose (Tom O.).

**REVIEW OF MINUTES FROM PREVIOUS MONTH'S MEETING:** Bob L. moved to accept the July Minutes. Debbie D. seconded and the motion passed.

# **REPORTS FROM BOARD:**

**CHAIRPERSON:** Michele G. – Sent agenda early, if you aren't going to be here let her know early on.

**SECRETARY:** P.J. V. – The contact list was passed for updating.

**TREASURER:** Carmel M. provided a report.

For July group donations of \$1,277.75. Sales from Venmo for literature and coins reached \$193.00.

Total income for the month was \$2,483.25.

Expenses included wages, literature and coin purchases, fees for venmo/paypal, and the answering service. Rent was \$300. Office supplies were higher this month at \$510, but the Microsoft fee expense should be refunded. She also paid quarterly federal taxes.

Negative \$348.45 on the month, however ending balance remains \$15,917.55.

She figured out an easier way to pay rent, with using a debit card at the counter at the Alano.

Still looking at whether a payroll company (Number Crunchers) might be too expensive.

Excel is getting easier, group donations are organized alphabetically and she is attempting to delete duplicates, working on getting it more organized.

**OFFICE MANAGER:** Lisa S. Written report was passed around. There was a recurring fee they had to contest and it was refunded. They purchased 200 red books/75<sup>th</sup> edition anniversary books, replica of the original books from 1939 with cardstock and original stories. They've been selling books fast and running out so they ordered a lot of books.

**OFFICE VOLUNTEER CHAIR**: Nancy C. provided a report. She has been training new office volunteers. Up to 4 now.

**TWELVE STEP CHAIR**: Jen S. absent, no report.

**WEBMASTER:** Heather L. absent, sent in report, she's been updating the newsletter with things that people send her.

**NEWSLETTER**: Jude H. has the September newsletter, which is also on the website. She is playing around with the black and white printing. She is looking for folks who want to share experience, strength and hope.

**BIRTHDAY/SPEAKER MEETING:** Julio F. Meetings are going well, good attendance. Rent is paid to Jan 2025. Meetings set up until Jan 2025. He is trying to get some Red Bluff meetings to participate. Michele G. didn't have an answer, she is doing what is based on the bylaws. Chair/Co-chair/Treasure/Secretary/Co-Secretary and office manager is invited. She is more inclusive and more people could be involved. Michele G. asks Lisa S. to bring it to the Board meeting.
